- NDC has failed to determine application 75147 in relation to landscape condition 6 imposed on planning permission 73623 (Temporary agricultural workers dwelling) (landscaping)
- Knowstone Parish Council do not consider that there has been economic or commercial justification provided, that supports the provision of extensions to the existing building.
- 3) Local residents have expressed concerns about light pollution from the existing building.
